PROP WEAPON RENTAL

RENTAL REQUIREMENTS

To rent, the recipient must:

1. be over twenty-one (21) years of age with valid identification
2. be permitted by local, state and federal law to purchase (additional requirements may apply)
3. complete necessary documentation (see attached form)

PROP SELECTION

As a service to our clients, we are available to assist in your rental decision for desired props. We can supply you with assorted pictures and descriptions to assist you, and to provide the most accurate prop for your production needs.

RENTAL AGREEMENT

To begin a rental, we will draft a rental agreement for your review. The agreement will list the items, prices, replacement values, terms, deposits, and charges associated with the rental. If satisfactory, **MUST** be signed by the recipient prior to shipment/pickup of the weapons/props. This rental agreement will be referenced on the rental invoice, and will include all charges and fees for the respective rental.

This agreement will also include a final billing total which may include adjustments such as, but not limited to, rental extensions, damage fees, late return fees, replacement charges, etc., upon return of the weapon. It is the recipient's responsibility to read and understand the terms and conditions of the agreement PRIOR to signing.

WEAPON RENTAL PRICING

Rental prices shown are for a minimum of seven calendar days, starting the day the prop leaves our facility (3-day wait period is not counted) and includes transit time, all holidays and weekends.

AUTOMATIC WEAPON RENTALS

Federal law prohibits the unlicensed possession of automatic weapons, including prop weapons for entertainment use. As a company policy, BPS does not release weapons of this type to the general public. Rentals are available on a DAILY basis and MUST include an armorer from BPS on set with the weapon at all times – **NO EXCEPTIONS**. Weapon of this nature are intricate in their operation and are not toys. Please ask for more information when calling.

PRODUCTION RENTALS

For prop rentals over one week, the price of the consecutive rental weeks decreases to ½ the initial rate. For prop rentals over two weeks in duration, we proudly offer competitive PRODUCTION RENTAL pricing, which applies to weapons, props, and blank ammunition. Please inquire when placing your order.

OPTION A - WEAPON TRANSFER

Our inventory of props includes various types of weaponry, including blank-firing, replica and rubber models. Please review the following information as to the requirements needed to receive the props you need.

Blank-Firing Weaponry:

The majority of our inventory is BATFE regulated blank-firing weapons which have been legally modified to fire only blank ammunition. To rent these weapons, the recipient must:

1. Be over the age of twenty-one (21)
2. Be a U.S. citizen and have valid identification (driver's license or other valid government issued identification)
3. Be a resident of the State of Florida (for rentals in Florida only)
4. Complete a federal background check using a **FORM 4473** with the Bureau of Alcohol, Tobacco, Firearms and Explosives ("BATFE"), through the Florida Department of Law Enforcement ("FDLE")(mandatory processing fee not to exceed \$15.00 applies) and receive an approval number
5. Complete a rental form and provide necessary documentation (i.e. proof of General Liability Insurance naming Boland Production Supply as Additional Insured)

****NOTE:** Florida state statutes require a three-day wait period on all handgun/revolver rentals, and no wait on long-gun/shotgun rentals. Please plan the production schedule accordingly to include this wait period. Recipient must initially visit our office location to complete FORM 4473, and then return three-business days later to pickup the prop(s).

SPECIAL NOTE TO CONCEALED WEAPONS PERMIT ("CWP") HOLDERS

If the recipient is in possession of a current, valid State of Florida Concealed Weapons Permit, the three-day wait period may be waived. However, BATFE requires a background check to be completed and receive an approval number be obtained. A copy of the CWP is required and attached to the FORM 4473 upon completion.

Replicas/Rubber Weaponry:

No federal background check is needed, but the recipient must:

1. Be over the age of twenty-one (21) with valid identification
2. Complete a rental form and provide necessary documentation

OPTION B - WEAPON DELIVERY

We offer two options for the recipient to take delivery of their rental: SHIPMENT & PICKUP

Blank-firing Weaponry (SHIPMENT and PICKUP)

SHIPMENT

Due to the sensitive nature of prop weapons, federal regulations require all blank firing weapons to be shipped directly to a gun store possessing a valid, current Federal Firearms License issued by the BATFE.

To ensure timely delivery, the recipient is responsible for the following:

- o Locate and obtain a gun store convenient to the recipient's address.
- o Inquire at the gun store any applicable fees or wait periods for the State.
- o Obtain a signed copy of the gun store's FFL license.
- o The gun store/recipient is to FAX/MAIL/FEDEX this copy to our mailing address. Save time – fax the copy to: (863) 318-1116! Upon receipt of the license copy, and the verifying the rental requirements have been met, BPS will ship the props to the address specified on the gun store's license.
- o Upon arrival of the props to the gun store, the recipient revisits the gun store and completes paperwork required for taking possession.
- o Handguns/Revolvers **MUST** be shipped and returned using a Next Day Air level of service. **No Exceptions!** Long-guns/Shotguns/Rifles may be shipped and returned using a Ground level of service. In the event of a multi-piece shipment, the mandatory level of service is Next Day Air.
- o Plan the production schedule accordingly for transit times. Inside the State of Florida, average delivery time is one business day. Please inquire at time of ordering for exact transit times.

Blank-firing Weaponry

PICKUP

- Clients are welcome to pickup their prop weapon rentals from our office location, when convenient. Please refer to the above section **WEAPON TRANSFER: Blank Firing Weaponry**, for the requirements and the necessary documentation the recipient needs to furnish.

RENTAL TERMS

- The return date listed on the rental agreement is the firm date the prop is required to arrive in our facility. All delays or errors as a result of courier services become the responsibility of the renting party and are invoiced accordingly. **Late returns are billed in weekly extensions starting the next day from the original return due date as reflected on the original rental contract. Charges shall be applied against the deposit credit card on file each week until the props are returned in satisfactory condition.**
- A rental deposit equal to the replacement value of the rental props SHALL BE due PRIOR to shipment. This must be secured against a VISA/MC/AMEX. This amount will be refunded to the cardholders account within 3 business days at the close of the rental, less any amount required to address any repairs/damage/rental overages.
- Blank ammunition is sold in a minimum quantity of fifty (50) rounds. **ALL AMMUNITION SALES ARE FINAL.** Blank ammunition is for SALE only.
- See below for additional rental information.

KEY POINTS TO REMEMBER

1. Plan your production schedule accordingly to adjust for delays in:
 - Transit time of signed, photocopy of gun store FFL (if applicable)
 - Transit time of weapon shipment
 - Payment verification
 - Unforeseeable delays or denials in FDLE approval

RENTAL RETURNS

BLANK FIRING PROP WEAPONS

The best alternative to return your blank firing props is to re-visit the gun store you used to take delivery. The owner of the gun store can arrange to have the firearms returned to our warehouse. Inquire at time of transfer about charges from the gun store owner for this service. **NOTE: Most public shipping centers (i.e. UPS STORE/Kinko's) will not ship live firearms.**

Remember – a rental shall incur additional charges for returns arriving past the RETURN DATE shown on your rental contract.

Pistols/Revolvers

According to Federal statutes, the shipment of handguns, including pistols and revolvers must be via a "Next-Day" AIR service (i.e. Federal Express Priority or UPS Red Label Next Day Air) only. We understand the use of this type of service might be costly, but we know the difficult issues encountered when accounting for a stolen/missing weapon. Please assist us in preventing such a dilemma.

Shotguns/Rifles

The return of our rental long guns, for example shotguns and rifles, may be shipped using any courier service and level available. UPS Ground/FedEx Ground are the best cost-effective and reliable methods available.

REPLICA/RUBBER PROP WEAPONS

To return replica and rubber props, use the same box in which the props were delivered. FedEx Ground or UPS Ground are cost-effective methods and can be utilized from any local shipping store. Package the props BEFORE entering a place of business to arrange for shipping, and that you insure the box for the total of the replacement cost as shown on your copy of the rental contract.

NEVER SHIP ANY WEAPONS VIA THE US POSTAL SERVICE!
ENTERING POSTAL PROPERTY WITH A FIREARM IS A FEDERAL CRIME
AND PUNISHABLE BY FINES AND/OR IMPRISONMENT.

BLANK AMMUNITION

Do not return blank ammunition or spent casings with the rental props – we do not accept returns or give credit against the rental for unspent rounds. Under no circumstances should this ever be shipped to our warehouse. Doing so could subject you to heavy fines and imprisonment in violation of Department of Transportation regulations.

PAYMENT OPTIONS

OPEN CREDIT ACCOUNT

An open credit account is available to our clients upon approval. Please request an application to be sent to you. Upon approval and account maturity, terms of Net 30 Days will be offered. Please note current account terms are Net 10 Days for all prop rentals. Transactions processed as Net Account transferred to Credit Card account will be assessed a 6% convenience fee.

CREDIT CARDS

We accept AMEX/VISA/MC for your convenience. Please complete the form “Credit Card Authorization Form” in the back of this catalog and fax it to (863) 318-1116, prior to paying with a credit card.

COMPANY CHECK/MONEY ORDER/CASHIER’S CHECK

We accept checks drafted on company accounts, money orders, or cashier’s checks (US financial institutions only). A \$29.00 fee will apply for all returned checks. Personal checks are accepted using only FedEx C.O.D. service. See **C.O.D. SERVICE** below for more information. Merchandise will ship upon payment check verification.

C.O.D. SERVICE

Utilizing Federal Express courier services, we offer a C.O.D. option to our clients who need to pay using a personal check. A \$10.00 fee per shipment applies. Sorry, no blank-firing weapons can make use of this service.

RENTAL DEPOSIT REQUIRED

A rental deposit equal to the replacement value of the props is required at time of rental. This deposit is to be placed against a credit card and will stay in force throughout the entire duration of the rental. Upon return of the props, the items will be inspected and the rental deposit shall be removed from the credit card for the entire amount, less any damages, if applicable. This process normally takes less than 72 hours after the return of the items.

RETURN POLICY

A twenty-five percent (25%) restocking fee may be applied to all returns. We will not accept any merchandise that has been opened, is returned in poor condition, or was a special/custom order. To ensure compliance with applicable shipping regulations, please contact us prior to returning any merchandise. **AMMUNITION SALES ARE FINAL - NO RETURNS.**
